

## JP Hospitality Investors Club concludes lease agreement for its hotel in Madonna di Campiglio with legal support from Wolf Theiss

This latest collaboration involved a Hotel in Madonna di Campiglio, Italy. The new operator, Treasurests Hospitality, will continue to run it under the lifestyle leisure brand "Casa Cook".

JP Hospitality acquired the hotel in Madonna di Campiglio – previously operated as Hotel Milano – last year. The hotel is located in the middle of northern Italy's top ski region in the Brenta Dolomites and is only about a minute's walk from the base station of the famous World Cup racecourse. During the summer, it offers guests an ideal starting point for hikes in the picturesque mountains and surrounding lakes.

Until now, the hotel comprised 44 rooms with a gross floor area of approximately 2,900m<sup>2</sup>. With the takeover by the new tenant Treasurest Hospitality, which will manage the hotel under the leisure brand "Casa Cook", the hotel is to be converted into a upscale alpine lifestyle hotel based on the 3R concept (refurbishment, rebranding, redesign) and expanded by 6 suites. A rooftop bar with a view of the World Cup ski slopes is also planned.

Gebhard Schachermayer, CAM and hotel expert at JPI Hospitality, commented on the successful conclusion of the hotel lease as follows:

"Casa Cook as operator is an ideal complement to our existing hotel activities and we are pleased to be the first investor to also bring Casa Cook to the mountains. There will be a lifestyle offering here that will cater to all holiday requirements of the highest quality. Many thanks to Wolf Theiss for once again providing excellent support and advice. We are already looking forward to the next joint project".
