Controversial IP directive provides new protections for right holders

The DSM Directive is one of the most controversial pieces of copyright legislation in the EU. It took 2.5 years from the publication of the Commission's proposal in 2016 and extensive discussions with and lobbying by rights holders, user organisations and platforms until the final text was adopted in 2019.

The most controversial / key provisions of the DSM Directive include:

- Art 17: This provision received wide media coverage under the non-technical term "upload filters". It introduced new obligations for online content-sharing service providers, making them directly liable for user posts which infringe copyrights, unless the they have made "best efforts" to obtain permission from and acted diligently to take down infringing content flagged by right holders – and to prevent future uploads thereof.
- Art 15: This provision also received wide media coverage under the non-technical, and incorrect term often used: "link tax". The media focus was partly a result of the fact that national initiatives of Member States to implement such a provision themselves have not been very successful in the past. Art 15 provides for a new ancillary right for press publishers established in a Member State.
- Art 18-22: These provisions aim at providing a high level of protection for content creators, including, for example,

a claim for an additional remuneration if the initial payment agreed on was disproportionately low when compared to the revenue generated by the exploitation of the work, the option for revocation of licenses if those works are not exploited and a claim for information on how one's works are exploited.


Contentious provisions have slowed implementation

The deadline for the implementation of the DSM Directive was **7 June 2021**.

Considering the controversial discussions at the EU level, it is not surprising that also on national levels there has been substantial lobbying in regard to the specific implementation of the provisions. In addition, a guidance document from the Commission on the most controversial provision, Art 17, was only released in June 2021, and Poland has challenged certain obligations under this provision at the CJEU (proceedings are pending). Finally, the EU Member States being confronted with the COVID-pandemic were also slowing the implementation procedure.

It is therefore not surprising that many Member States have failed to implement the DSM-Directive in time. In the following table we provide an overview on the status of implementation in Central and Eastern Europe, where most countries have not implemented the directive yet.

Public consultations in view of the implementation of the DSM Directive were initiated in June 2020 by the Ministry of Culture. More than 20 submissions were presented by different actors, such a telecoms, artist unions, Google and Facebook.

In March 2021, the Ministry of Culture involved the Bulgarian Patent Office and organised a working group comprised of representatives of different institutions and organisations to deliver the first draft of the bill.
